Monthly commentary, April 2025

SKAGEN m2 had a strong April, recovering some of its first-quarter losses and outperforming both the global real estate market and the broader equity index for the month.

US ten-year Treasury yields were highly volatile, fluctuating by around 50 basis points within a few days following the surprise impact of Trump's "Liberation Day," which rattled both bond and equity markets globally. Despite this turbulence, listed real estate has proven slightly more resilient than the broader equity market so far this year. The sector continues to benefit from healthy cash flows, and there are encouraging signs that the real estate cycle is moving in a positive direction. Historically, listed real estate tends to lead in early-cycle recoveries, indicating that the current downturn may present a compelling entry point.

April's top contributor to fund performance was European healthcare real estate operator Aedifica, followed by self-storage company Shurgard and Swedish social infrastructure firm Intea. Aedifica delivered a strong Q1 report, featuring improved margins, solid like-for-like rental growth, positive portfolio revaluation, and reduced leverage.

On the downside, the main detractors were all US-based: residential rental company Independence Realty Trust (IRT), cold storage operator Americold, and global logistics REIT Prologis. IRT's Q1 report was broadly in line with expectations, showing some positive momentum in its acquisition pipeline and leasing activity, although blended rental rates dipped slightly and leverage increased modestly.

We remain focused on resilient companies operating in trend-driven subsegments that are undervalued but have the potential to thrive in various market conditions. These companies typically have solid balance sheets, an increasingly important factor as financials improve across the sector. The portfolio remains strategically overweight in high-growth real estate segments, including digital real estate, housing, and warehouses – sectors poised to benefit from structural demand trends and a shifting yield curve as interest rates decline. Given that real estate is the world's largest asset class, it deserves your attention – don't overlook the opportunities it presents!


